TERMS AND CONDITIONS

Issued on 24 September 2024

To celebrate the launch of the 2025 Epic Australia Pass, we'd like you to share your favourite moment captured on video around Perisher, Falls Creek or Hotham in the "Magic Moments" competition.

By entering the "Magic Moments" competition, you agree to the following terms and conditions ("**Terms and Conditions**"):

- 1. The "Magic Moments" competition is promoted by Perisher Blue Pty Limited, ABN 82 061 232 488, as trustee for the Snow Trust, ABN 29 420 214 757 (the "**Promoter"**).
- 2. Information provided by the Promoter about how to enter the "Magic Moments" competition forms part of these Terms and Conditions.

3. When can you enter the "Magic Moments" competition?

The "Magic Moments" competition opens on **Tuesday, 24 September 2024** at noon (Australian Eastern Standard Time) and closes at midnight at the end of **Wednesday, 16 October 2024** (Australian Eastern Daylight Time).

4. Are you eligible to enter?

- 4.1. Entry is only open to residents of Australia with an Australian residential or postal address, aged 18 years or over, at the time of entry, excluding directors, officers, management, employees and their immediate families of the Promoter and its affiliates, related bodies corporate and partners ("**Eligible Entrants**").
- 4.2. To enter, Eligible Entrants must before midnight at the end on **Wednesday**, **16 October 2024** (Australian Eastern Daylight Time):
 - a) purchase a 2025 Epic Australia Pass or a 2025 Epic Australia Adaptive Pass, and
 - b) submit a video captured in or around Perisher, Falls Creek or Hotham (max 15 seconds), along with a written description of why this magic moment is unforgettable to them (max 500 characters), at <u>https://www.epicaustraliapass.com.au/epic-australia-pass-road-trip-competition</u>, and
 - c) share their video entry to their personal Instagram or Facebook account and include the competition hashtag "#epicaustraliapassroadtrip" to their post.

5. What else do you need to know about entry?

- 5.1. Each Eligible Entrant warrants that their entry, including video footage:
 - a) is the Eligible Entrant's own creation, and

- 5.3. The time of entry is the time the entry is received by the Promoter at <u>https://www.epicaustraliapass.com.au/epic-australia-pass-road-trip-competition</u>.
- 5.4. All valid entries will be entered into the "Magic Moments" competition.

- 5.5. The Promoter is not responsible for late or lost entries, including if the competition portal is unable to accept an entry.
- 5.6. The Promoter reserves the rights:

 - b) to disqualify an entry if the entrant who submitted that entry does not satisfy these Terms and Conditions, or interferes with the "Magic Moments" competition, including the entry process.

6. How will entries be judged?

- 6.1. The Promoter will judge the entries between Tuesday, 22 October 2024 at 8am (Australian Eastern Daylight Time) and Tuesday, 29 October 2024 at 5pm (Australian Eastern Daylight Time) at their offices.
- 6.2. Entries will be judged on the basis of being engaging and awe-inspiring, unforgettable and showing personal and emotional connection to the Australian mountains. Chance plays no part in determining the winning entry.
- 6.3. The Promoter's decision as to the twenty (20) winning entries is final and no correspondence will be entered into.

7. When will the winning entries be announced?

- 7.1. The Promoter will notify the winning Eligible Entrants by email or SMS on **Wednesday, 30 October 2024** or as soon as possible after that date.
- 7.2. - 11.3. These Terms and Conditions are subject to the laws of New South Wales, and all entrants submit to the nonexclusive jurisdiction of the Courts of New South Wales.

12. Promotion of your entry and privacy

- 12.1. By submitting your entry, you give permission to the Promoter to publish, repost and use your entry, including any part of your entry.
- 12.2.
